It is characterized by severe eosinophilia, a blood disorder in which the white blood cells increase to an abnormally high level. L-Tryptophan occurs naturally in many foods and investigation has not established whether it or an impurity introduced during manufacture or distribution is the cause.

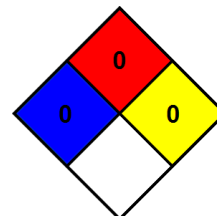
