It is characterized by severe eosinophilia, a blood disorder in which the white blood cells increase to an abnormally high level. L-Tryptophan occurs naturally in many foods and investigation has not established whether it or an impurity introduced during manufacture or distribution is the cause. To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

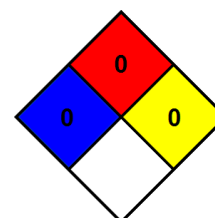
